I recognize, especially in the event I choose not to exclusively utilize electronic or remote options, I may come into contact with, or be in close proximity to, other individuals simply by being part of, or assisting in, a real estate transaction. I understand that in light of the pandemic it is not always possible to determine who has or has not been exposed to, or contracted, the COVID-19, or similar virus and that due to the nature of said viruses, nearly any individual could spread the disease.
