## FIRST AMENDMENT TO DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS FOR NORTHRIDGE VILLAGE

This First Amendment to Declaration (the "First Amendment") is made as of the date set forth below as follows:

- 1. The Declaration Establishing Covenants, Conditions and Restrictions for Northridge Village of the Northridge IX Subdivision was recorded January 31, 2020 as Instrument No. 666792 in the records of Blaine County, Idaho (collectively the "Declaration").
  - 2. Section 3.1.6 of the Declaration shall be amended to read as follows:
    - 3.1.6. <u>Fencing</u>. No fencing may be built within twenty (20) feet of the property line on either First Avenue North or Second Avenue North. No fencing may be built within twenty (20) feet of the property line on the alley side of the house, or closer to the property line than the wall of the house closest to the alley side property line. Fencing may not exceed seventy-two (72) inches in height. Chain link fencing is not allowed.
  - 3. All other provisions of the Declaration shall remain the same and in full force and effect.
  - 4. The undersigned, as president of the Northridge Village Owners' Association, Inc., and an owner of at least two-thirds (2/3) of the Lots in the Northridge Village, confirms that this amendment is made in compliance with Section 7.2 of the Declaration.
